2006 SAN JOAQUIN COUNTY UC COOPERATIVE EXTENSION MID-MATURITY PROCESSING TOMATO VARIETY TRIAL FIELD DAY


MONDAY **OCTOBER 9, 2006** 10 AM—12 PM

This year's mid-maturity variety trial includes 16 replicated varieties and an additional 5 varieties in single plots. The trial was established by transplanting on May 24th and was furrow-irrigated. Cooperators are Hal and Keith Robertson (K & H Farms) of Tracy.

The July heat wave resulted in a split fruit set which has delayed the harvest date from what was expected. However, the crop looks good and there are visible differences between the varieties. Come take a look!

To reach the field, exit I-5 at Highway 33 (S. Ahern Road). Head NW on 33 and take the next right on Linne Road. Follow Linne over I-5 and the field will be the first tomato field on your right as you descend down the overpass. Look for a UCCE sign and turn right at the dirt road on the east side of the field and head to the SE corner of the field where the trial is located.
